Amazingly, two large snowstorms occurred that weekend - one in the Northeast and another in the west/Midwest, so many of our members could not attend. The one-

day symposium entitled "Climbing the Career Ladder: Strategies, Tools and Skills" was such a success, that we decided to hold it again in the late spring or fall of 2006 so more of you can attend this valuable session. A Brief Bio of one of our newlycertified women!

Virginia R. Litle, M.D. graduated from the Brown-Dartmouth Program-in-Medicine and completed an internship and residency in General Surgery at the University of California, San Francisco. Dr. Litle subsequently completed a Surgical Oncology fellowship at the University of Pittsburgh Medical Center followed by a Cardiothoracic residency also at the University of Pittsburgh. Dr. Litle has extensive experience in thoracoscopic/laparoscopic (minimally invasive) esophagectomy,

laparoscopic anti-reflux surgery and repair of giant paraesophageal hernias and minimally invasive palliation of advanced airway and esophageal malignancies including use of stents and photodynamic therapy. Her translational research interests include molecular detection of occult metastatic disease in lung and esophagus cancer. She is currently an Assistant Professor of Surgery in the Department of Cardiothoracic Surgery at Mount Sinai Medical Center in NYC.
